**Directions to Locations (in event order)**

**Old Bridge - Department of Public Works - 1 Old Bridge Plaza, 08857**

**From The North:** Follow Route 9 South and exit for Route 516 East/Matawan. Merge onto Route 516 East and travel approximately 1/4 mile. Municipal Center will be on the left. Be sure to make a left into the second driveway from Route 516.

**From The West:** Take Route 18 South (toward East Brunswick) passing Brunswick Square Mall and the Main Street exit on the right. Take exit for Matawan/Route 516 East. Follow Route 516 East for approx. 3 miles. After passing the interchange for Route 9, go approximately 1/4 mile. The Municipal Center will be on the left. Be sure to make a left into the second driveway from Route 516.

**Monroe - Thompson Park (Parking lot across from Manalapan Lake) 08831**

**From the North and South:** Take NJ Turnpike (Exit 8A) or Route 130 and exit onto Forsgate Drive (Route 32) which turns into County Route 612. Follow for approximately 3 miles, heading into Jamesburg and just before reaching Route 522, turn right into Thompson Park. Once in the park, make your first left and the parking lot will be on your right, across from the Lake.

**Metuchen - Edgar Middle School - 49 Brunswick Avenue, REAR PARKING LOT 08840**

Take Route 1 to County Route 531 / Main Street north towards Metuchen. Travel 0.3 miles and turn left onto Brunswick Avenue. Follow Brunswick Avenue to end. Turn left onto Lake Avenue. Rear Parking Lot will be on your left.

**Highland Park - Senior Center - 220 South Sixth Avenue, 08904**

**From the North:** Take Route 27 South and turn left onto South Sixth Avenue. Go two blocks and the Senior Center will be on the right hand side in the third block.  
**-OR-** Take Woodbridge Avenue (Route 514) West and just before reaching the intersection with Route 27, turn left onto South Sixth Avenue. Go two blocks and the Senior Center will be on the right hand side in the third block.

**From the South:** Take Route 27 North and turn right onto South Sixth Avenue. Go two blocks and the Senior Center will be on the right hand side in the third block.

**South Amboy - Municipal Building - 140 North Broadway, 08879**

**From Route 35 South:** On Route 35, turn slight right toward South Amboy Business Center. Stay straight to go onto Main Street. On Main Street, at the first light, make a left onto Broadway. South Amboy Municipal Building will be on the right, approximately 0.2 miles.

**From Route 35 North:** On Route 35, Turn right onto CR-670/Washington Avenue. On Washington Avenue make a right onto Broadway. South Amboy Municipal Building will be on the right, approximately 0.2 miles.

**Take Route 9 South:** Take the ramp toward South Amboy Business Center. On Main Street, at the first light, make a left onto Broadway. South Amboy Municipal Building will be on the right, approximately 0.2 miles.

**Take Route 9 North:** To Main Street (At the underpass, do NOT make the right to continue on Route 9). On Main Street at the second light, make a right onto Broadway. South Amboy Municipal Building will be on the right, approximately 0.2 miles.

**South River - Department of Public Works - 9 Ivan Way, 08882**

**From the North and the South:** Take Route 18 to Main Street/Route 535. Travel just under 1 mile and turn right onto Jackson Street. Follow Jackson and turn right onto Whitehead Avenue. Follow Whitehead Avenue for about 1.2 miles and turn left onto Ivan Way.

**New Brunswick - High School Parking Lot - 1000 Somerset Street (Route 27), 08901**

**From Route 287:** Take Route 287 to Exit 9 (CR-514/RIVER Road toward HIGHLAND PK). If coming off Route 287 North, make a left at the light onto River Road. If coming off Route 287 South, make a right at the light onto River Road. Continue to follow River Road (Route 18 South). After Landing Lane intersection, turn right to continue on Route 18 South (stay in right lane). Exit onto George Street toward Route 27 South/New Brunswick. Turn right at Albany Street/Route 27. Continue to follow Route 27/French Street. French Street becomes Somerset Street. Arrive at 1000 Somerset Street on left (opposite Churchill Avenue).

**From NJ Turnpike:** Take NJ Turnpike to Exit 9. Take Rt. 18 North to Albany Street (Route 27 South). Continue to follow RT-27/French Street. French Street becomes Somerset Street. Arrive at 1000 Somerset Street on left (opposite Churchill Avenue).

**Edison - Municipal Bldg. - 100 Municipal Boulevard, 08820**

**From the NJ Turnpike:** New Jersey Turnpike to Exit 10 to Route 287 North. Exit for Route 27 South, New Brunswick. At fourth traffic light, make right onto Municipal Boulevard (Opposite Reydel Volkswagen) and proceed to Complex at the end of Municipal Boulevard on right.

**From the Garden State Parkway South:** Garden State Parkway South to Exit 130 to Route 1 South. Route 1 South to Route 287 North. Exit for Route 27 South, New Brunswick. At fourth traffic light, make right onto Municipal Boulevard (Opposite Reydel Volkswagen) and proceed to Complex at the end of Municipal Boulevard on right.

**From Garden State Parkway North:** Garden State Parkway North to Exit 127 to Route 287 North. Exit for Route 27 South, New Brunswick. At fourth traffic light, make right onto Municipal Boulevard (Opposite Reydel Volkswagen) and proceed to Complex at the end of Municipal Boulevard on right.

**Woodbridge - Public Works - 225 Smith St., Keasbey, 08832**

**From Route 1 or NJ Turnpike:** Take either Route 1 North (or N.J. Turnpike North to Exit 10) and get onto Route 440 North toward Staten Island (Route 287 South becomes Route 440 North). Take the exit for Smith Street / Riverside Drive/ Fords. Follow the signs for Smith St., bearing left toward Keasbey. Go through one light. Get into the right lane and turn right at the sign onto access road for Woodbridge Public Works, between bridge overpasses. Follow access road to end. Turn right into Public Works Yard.

**From Route 9 / Route 35:** Take Route 9 North to Route 35 North. Stay in the right lane following signs for Route 35 North and go around the circle. Stay right and take the Route 35 Victory Bridge across the river. Turn left at the first light onto Smith Street. Travel less than 1 mile and stay in the left lane. Just after passing under the bridges, take the left lane U-turn. Yield, then immediately get into the right lane. Turn right at the sign onto access road for Woodbridge Public Works, between bridge overpasses. Follow access road to end. Turn right into Public Works Yard.

**Plainsboro - 641 Plainsboro Road, 08536**

**From the New Jersey Turnpike:** Use Exit 8A; Bear right at exit onto Route 32 west. Turn left at second traffic light onto Route 130 South. Turn right at third traffic light onto Dey Road. Immediately after second traffic light, turn left into Municipal Center parking lot.

**From Route 1:** Exit at Scudders Mill Road. Turn right at fifth traffic light onto Dey Road. Immediately turn left into Municipal Center parking lot.

**Monroe - Thompson Park (Parking lot across from Manalapan Lake) 08831**

See directions on the front page.

**South Brunswick - Beech Woods Park - 37 Beekman Road, Monmouth Junction 08852**

**From the North:** Take Route 1 South to Beekman Road (right lane exit). Travel approximately 500 feet and the entrance to Beech Woods Park will be on the right.

**From the South:** Take Route 1 North to the North Umberland Way / Beekman Road exit. Take off ramp to end and make a left onto Beekman Road. Once you have crossed Route 1 the entrance to Beech Woods Park will be on the right.

**South Plainfield - PAL Bldg./Recreation Center - 1250 Maple Avenue, 07080**

**From Parkway North and Route 287 North:** Take the Garden State Parkway North to Exit for Route 287 North. Take Route 287 North to Exit 4 (Durham Avenue, South Plainfield). Turn right on to Durham Avenue. Approximately 1/4 mile bear to your right, road changes to Hamilton Boulevard. Turn right on to Maple Avenue. Proceed to P.A.L. Building approximately 1/2 mile on your right.

**From Route 287 South:** Take Exit 5 (Edison) and turn left at end of ramp onto Stelton Road. Take first right onto Hamilton Boulevard. At your second light, turn left to stay on Hamilton Boulevard. Travel through two additional traffic lights to Maple Avenue. Turn right on to Maple Avenue and proceed to the P.A.L. Building approximately 1/2 mile on your right.

**Milltown - American Legion Parking Lot - 4 JF Kennedy Drive 08850**

**From Route 1:** Take Route 1 to Milltown Road East (towards Milltown) which turns into Main Street. Travel about 1 mile through several traffic lights and just after crossing a small bridge, turn left at traffic light onto Washington Avenue. The American Legion will be on the right (opposite Post Office).

**From Ryders Lane:** Take Ryders Lane to Washington Avenue towards Milltown. Travel less than a mile and just before reaching Main Street, the American Legion will be on the left hand side (opposite Post Office).

**Carteret Community Center - 100 Cooke Avenue, 07008**

**FROM NEW JERSEY TURNPIKE:** Take the New Jersey Turnpike South to Exit 12 toward Carteret/Rahway. Bear left at toll booth. At the first traffic light, make a right. At the next traffic light, make a left onto Roosevelt Avenue. At the next traffic light (B.P. Amoco, Paul's Gulf, Wachovia Bank) proceed straight to enter Washington Avenue. At the next traffic light, make a left to continue on Washington Avenue. After seven blocks, make a left onto Cooke Avenue. After 3 blocks, end at Borough Hall and the Thomas J. Deverin Community Center / Library is on the Left.

**FROM GARDEN STATE PARKWAY:** Take the Garden State Parkway North to exit 129. Look for the New Jersey Turnpike North/195 signs. Take the New Jersey Turnpike North to Exit 12 toward Carteret/Rahway. Bear left at toll booth. Bear left at toll booth. At the first traffic light, make a right. At the next traffic light, make a left onto Roosevelt Avenue. At the next traffic light (B.P. Amoco, Paul's Gulf, Wachovia Bank) proceed straight to enter Washington Avenue. At the next traffic light, make a left to continue on Washington Avenue. After seven blocks, make a left onto Cooke Avenue. After 3 blocks, end at Borough Hall and the Thomas J. Deverin Community Center / Library is on the left.
