### **ORDINANCE #12-06**

AN ORDINANCE AMENDING THE "REVISED GENERAL ORDINANCES OF THE BOROUGH OF JAMESBURG" BY AMENDING AND SUPPLEMENTING CHAPTER IV, ENTITLED "GENERAL LICENSING", SECTION 7, "BINGO; RAFFLES"

**BE IT HEREBY ORDAINED,** by the Borough Council of the Borough of Jamesburg in the County of Middlesex that the "Revised General Ordinances of the Borough of Jamesburg" are heretofore amended as follows:

## **SECTION ONE**

Chapter IV (General Licensing), Section 7 (Bingo; Raffles), of the "Revised General Ordinances of the Borough of Jamesburg" is hereby amended and supplemented as follows (additions shown <u>underlined</u>):

### 4-7 BINGO; RAFFLES.

**4-7.1 Purpose**; **Administration**. This section is for the purpose of regulating all games of chance, held, operated or conducted within the Borough, pursuant to the acts of the Legislature of the State of New Jersey, known as the Bingo Licensing Law and the Raffles Licensing Law, and in accordance with the rules and regulations issued or to be promulgated by the Legalized Games of Chance Control Commission in the Department of State of the State of New Jersey. All applications, licenses and proceedings in connection therewith shall be subject to the provisions of the acts and rules and regulations and to any laws, rules and regulations hereafter enacted and shall be further subject to the provisions of this section. The Municipal Clerk is hereby delegated the authority to act as the "issuing authority" to approve the granting of raffle and bingo licenses.

# **SECTION TWO**

1. That the provisions of this ordinance shall be severable. In the event that any portion of this ordinance is found to be invalid for any reason by a court of competent jurisdiction, such

judgment shall be limited in its effect only to the portion of the ordinance actually adjudged invalid and shall not be deemed to affect the operation of any other portion thereof, which shall remain in full force and effect.

- That this ordinance shall take effect immediately upon final passage and publication in 2. accordance to the law.
- 3. That all other ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.
