All food vendors are required to obtain a Temporary One Day Food Handler's License at the Jamesburg Borough Hall (**Fee: \$10.00**)- 131 Perrineville Road, Jamesburg, NJ 08831. A copy of the Middlesex County Health & Regulations will be provided to you at the that time. Bring your permit with you on the day of the event.

### **Open Flame Grill: (Permit \$54.00-Separate Check, payable to Jamesburg Borough- Fire Prevention)**

Vendors must obtain a Permit from Brian Wright, Jamesburg Fire Inspector at the Jamesburg Borough Hall. **The fee is \$54.00.** Jamesburg Borough Hall, 131 Perrineville Road, Jamesburg, NJ 08831

**EVENT RULES & REGULATIONS**

- 1.) Vendors must report to the Registration Table located on West Railroad Ave. & Church St. (In front of the old PNC Bank.) **Vendors may begin to arrive and check in at 8:30 AM and set up on West Railroad Avenue between Church & Front Streets.**
- 2.) There are **NO ASSIGNED VENDOR SPOTS** vendors it is highly recommended to arrive promptly for a good spot.
- 3.) Vendors may bring their cars early to unload their goods but then must move their cars out of the booth area and park on a side street. Event coordinators will assist if necessary. **NO UNAUTHORIZED VEHICLES ARE PERMITTED, INCLUDING GOLF CARTS, POWERED SCOOTERS OR POWERED BIKES.** Only emergency vehicles and event staff will be authorized to drive on West Railroad Ave. during the event. West Railroad Ave. will be closed to thru traffic at 11:00 a.m.
- 4.) All vendors must comply with the tents set herein as part of the agreement for the event. Failure to comply will result in immediate termination of the booth and forfeit of any and all fees at the discretion of the event coordinator.
- 5.) Each vendor will provide their own tents, tables, chairs, garbage bags or other fixtures & displays. If you need assistance, the event coordinators will be on hand to help.
- 6.) Vendors must leave their table area clean of garbage during and after the event.
- 7.) **The sale of any black powder or gunpowder use devices is prohibited. This included caps, poppers or any type of explosive device or firearm.**
- 8.) All paperwork (including Check or Money Order made out to the Jamesburg Recreation) must be completed & mailed or dropped off at the Jamesburg Borough Hall, 131 Perrineville Road, Jamesburg, NJ. 08831 Attn: Samantha Rampacek or Sue Boulogne- Public Events by **Monday October 14, 2019.** Registrations received after October 14<sup>th</sup> add \$5 to the table price.
- 9.) Vendors may also pay the day of the event by going directly to the registration table located on West Railroad Avenue & Church Street (in front of the old PNC Bank.) Add \$5 to table price.
- 10.) **PLEASE NOTE: THERE WILL BE NO REFUNDS AFTER YOUR CHECK/MONEY ORDER HAS BEEN RECEIVED.**
